to none; the medical equipment is cutting edge, but while we are long on expertise and equipment, we are very short on space. The space we are seeking to build will allow families to remain close to those they love while at the same time, allow the clinical staff the space necessary to perform their skills and provide their miraculous care .

The pace is also escalating toward the construction of a Comprehensive Cancer Center. Cancer is the world's leading cause of death. According the American Cancer Society, it costs more in productivity and lost lives than any other disease such as AIDS, malaria or the flu. And although no one wants to redirect funding away from fighting those diseases, we need to bring support for cancer care in line with its devastating impact on society. Georgia is a leader in this regard with the creation of the state-wide Cancer Coalition. Central Georgia has been recognized as a Center of Excellence and it is incumbent upon all of us to support this vision. A Comprehensive Cancer Center will be built across from the Luce Heart Institute. By having oncology services coordinated and under one roof, patients and families will be guided through a remarkably supportive system of care by a coordinated clinical team . Likewise the healing impact of this medical team will be far more effective than the sum of their individual parts. We are excited about this potential to fight, as a unified army, this insidious disease. We hope you will be generous in supporting this tremendous effort.

Our economy is far from being out of the woods. We are, however, all in the woods together, which promotes a greater sense of togetherness and mutual responsibility than we have experienced in decades. On behalf of countless patients and their families, I thank you for all your past generosity and only urge you to continue as we quicken the pace toward new frontiers and accomplishments. Together everything is possible.

Medcen Supports More Than Bricks and Mortar...

Here at Medcen, we've been so focused and excited about the fruition of Pine Pointe at Hospice of Central Georgia and the beginning of our new campaign to renovate and expand the ICU, we haven't given much attention to the Research and Education Grant program designed to support the physicians of MCCG. Recently though, one of our board members asked what types of studies have received grants and whether there had been any significant outcomes

because those funds were made available. That question initiated quite a bit of conversation and, ultimately, this article.

Picturing hundreds of lab rats and bubbling beakers I set out to find an interesting research program. But the story actually found me when I happened to run into Dr. Sabry Gabriel in a local restaurant and he asked me to give him a call. We set up a

time to meet. I had seen him and his wife not too long ago at the Casino Night fund raising event for The Children's Hospital and thought perhaps he was following up with something there. Not the case at all – he wanted to ask me about applying for a Research and Education Grant from Medcen. So I asked him how he knew about Medcen's grant program and he explained he'd gotten one before!

Sensing a good story, I began to practically "grill" Dr. Gabriel. Luckily, he graciously spent an hour telling about the project he initiated and how it has greatly benefited untold numbers of individuals, mainly in Intensive Care Units.

To summarize his story, he was a resident and working in Medical Center's ICU when he had an idea for an age old problem: how to get a patient's feeding tube to go around all the twists and turns inside the body. He had an idea for a special instrument and estimated it would require \$5,000 of additional funds to build a prototype. Being a resident straight out of medical school, he had no funds of his own, but was encouraged by another physician, Dr. Walter Treadwell, to submit a Research and Education grant application to Medcen Foundation.

A five thousand dollar grant was approved and Dr. Gabriel proceeded to order his special instrument – a magnet! A rather large magnet which could be used outside

the body to direct a much smaller magnet attached to the tip of the feeding tube inside the body. The next step was to find someone to try his device on for the first time. This obstacle was quickly overcome when his wife, who at the time was working on her degree to become a registered nurse, volunteered to be his first patient! Oh, the things we do for love!

Well to make a long, very interesting story short, it was a highly successful experiment which resulted in a \$1.2 Million grant from the National Institute of Health. Dr. Gabriel was also published in one of the most prestigious medical journals: Critical Care Medicine.

Today, the "Gabriel Feeding Tube," is not only used in hospitals nationwide, but is widely used among our troops in Iraq and Afghanistan. Stop and think about that a minute ~ a life-saving device used throughout the country and to save the lives of our heroic servicemen and women ~ started by a \$5,000 grant from Medcen's Research and Education Fund. It was an idea from a young resident physician at The Medical Center in Macon, Georgia, who saw a rather simple solution to a serious problem. Dr. Gabriel explained some of the benefits of the feeding tube, including the ability to conduct the entire procedure bedside, greatly reducing the risk of infection and leading to far better outcomes.

We are fortunate to have Dr. Gabriel in our midst. He reminds us we should have a much greater appreciation for the doctors and nurses who apply for Research and Education Grants for they are the ones who "are an invaluable resource to advancements being made in medicine." How often we overlook or take for granted the research and education being done to improve the quality of healthcare right here at The Medical Center of Central Georgia. It somehow takes place "behind the scenes" but we want, with Dr. Gabriel, to bring it "front and center" so our donors, patients and families can appreciate the commitment of our clinical staff to staying on the leading edge of health care.

Have you ever participated in the Susan G. Komen Race for the Cure? When you see the pink running lady embroidered and emblazoned on all manner of wearable items such as hats, scarves, socks, polo shirts, does it serve as a reminder to you to schedule your mammogram? Does it remind you to encourage your wife, friend, sister, or niece to schedule theirs? Well, it's about to.

Recently I met with Rebecca Weathersby, RN and Carol Ann Lindsey, RN, at The Central Georgia Breast Care Center at the Medical Center of Central Georgia to review the outcomes of a program started in August of 2009 with a grant of \$30,000 received from the Susan G. Komen Race for the Cure. Both are strong supporters of the program whose objective is to provide free screening mammograms and additional breast health services to the underserved and underinsured women of Central Georgia.

It's always exciting to receive a grant, but it is truly gratifying when you learn someone's life was saved because of it. I'm referring to Teresa Flowers, a 51-year old woman from Twiggs County, who had seen the Susan G. Komen Race for the Cure symbol hundreds of times, but never thought too much about it ~ until her sister-in-law encouraged her schedule a mammogram. Teresa had skipped it for two years because she couldn't afford it. Her sister-in-law was adamant she make an appointment. So Teresa called her doctor and he helped her work out a way for her to pay for the mammogram. Neither one was aware at the time she could have it done for free at The Central Georgia Breast Care Center (CGBCC).

She had the mammogram and received a call not long after saying something looked suspicious and she needed to come

back for another diagnostic mammogram. Again, she didn't have the funding capability to cover the cost of a second mammogram. Again the doctor's staff helped her by referring her to the free care provided by CGBCC. It goes without saying she was diagnosed with breast cancer.

Teresa was referred to Dr. Arnold Conforti who participated in the program and put her in touch with Rebecca. Not a moment's time was wasted and Teresa found herself in a small private conference room with Rebecca -- sweet, caring, knowledgeable and experienced in this specialty area, Rebecca. "She explained and explained detail to detail" said Teresa during our interview. Teresa couldn't say enough about how kind and helpful this special "bunch of people" at CGBCC are.

That was December 2009, I met Teresa in May 2010. She told me when she first was diagnosed, she felt as if she was in a dream and it wasn't happening to her and that she'd wake up and be okay. Well it wasn't a dream, but she is okay. Because of a path made possible by so many who walk, run, or in any other way support the Susan G. Komen Race for the Cure, who in turn support The Central Georgia Breast Care Center, she's very much okay. She has recovered beautifully because they found the cancer early. Today she is alive and happy to be picking up the phone reminding her friends to schedule their mammograms at the CGBCC.

In closing, Teresa didn't know the story about how Susan G. Komen's sister vowed to help other women with breast cancer and said she'd like to thank her: "I don't know her - I don't know God, but I know he's there. You can still get attached."

Stephanie Lampp - Dublin, GA

Stephanie Lampp made her first donation to The Children's Hospital in honor of her bridesmaids when she was planning her wedding. She could have never imagined the relationship she would eventually have with The Children's Hospital.

After many months of praying and hoping, finally the Christmas present Daniel and Stephanie had dreamed about was happening - they were expecting their first child. Much to their surprise and delight, they found out they were having a girl, and they named her Danilynn. Stephanie's pregnancy proceeded normally, with no complications, until May 29, 2009, when she was placed on bed rest for extremely high blood pressure. By June 4, Stephanie was admitted to Fairview Hospital in Dublin and was diagnosed with HELLP Syndrome, which stands for H-hemolysis, EL-elevated liver enzymes, LP-low platelet count. With this critical diagnosis, Stephanie was transferred to The Medical Center of Central Georgia.

From June 4th to June 10th, doctors worked to control the illness. The plan was for Stephanie to stay in the hospital until she was 34 weeks pregnant and then deliver the baby. As a precaution, she was given steroid shots to develop Danilynn's lungs, but on June 10th, a test showed all Stephanie's levels spiraling out of control. The doctor came in and said, "We are having this baby right now." The doctor also gave Daniel and Stephanie news that there was a chance of neither Danilynn nor Stephanie surviving. On hearing this, Stephanie said to Daniel "I loved you, and that I know I am going to heaven, but to take care of my baby." As they prepared Stephanie for a C-section, Daniel held Stephanie's hand through the entire procedure. When Danilynn was born, her cry "sounded like a little cat" said Stephanie. She entered the world at 2lb 9oz. Immediately after birth,

Danilynn was transferred to the Neonatal Intensive Care Unit of The Children's Hospital. Stephanie didn't get to see her miracle baby until Danilynn was 2 days old because she had to remain on bed-rest to finish treatment for her HELLP syndrome. All the predictions that the staff gave them were true, it would be a roller coaster ride; up one minute and down the next, with Danilynn's actual birth just the beginning. Stephanie and Daniel stayed in Macon for the next two months, both at The Ronald McDonald House and at a local Marriott, with the help of The Children's Miracle Network and The Marriott Rewards Program.

When Stephanie made her first donation to CMN, her idea was to "pay it forward," and her own experience shows how important that is. With the help of CMN, the staff of the Neonatal Intensive Care Unit, and the Dublin community, Danilynn was discharged to go home with Mom and Dad on August 7, 2009, weighing in at 4 pounds. Since being home, both Stephanie and Daniel have been active participants and advocates for The Children's Hospital. "What a comfort it is to know that we have a Children's Hospital so close that will not turn our child away, a hospital that will treat her no matter what her race, income, or if she has insurance."

Danilynn just recently celebrated her first birthday and has reached all her developmental milestones. To look at her now, you would never imagine that she was a premature baby! She is full of spunk and life and is just a joy to all that she meets! She is truly a miracle!

With the support The Children's Hospital receives from our faithful donors, The Lampps included, The Children's Hospital will continue to make miracles happen -- legacy of The Children's Hospital for the children of Central Georgia.

ICU Kick Off

Henry Koplin Gathers Friends for Cocktails and Conversation

So much to do and so little time! How do you get the word out about Medcen's newest campaign to renovate and expand the ICU? Since I'm just beginning to get in the world of facebook and twitter I called on a good friend and new member of the Board of the Medical Center of Central Georgia, Henry Koplin, to help me kick-off the new project. More than willing to help with a good cause, Henry and I met at his home to begin plans for the event.

After reviewing the layout of his kitchen, dining room, and patio, we sat down in his comfortable living room to talk about the project itself and what goals we're working to achieve. Wanting to keep things simple I explained some of the key points about the need for a new Critical Care Center. The current facility was opened in 1983 and quite frankly, we've not only outgrown it, but the manner in which ICU care is delivered has changed dramatically since then. Many procedures are now conducted beside making it almost impossible for the staff to move around much less have a family member present. Additionally, there are only 2 small consult rooms for families to meet with physicians in private. Scientific evidence abounds about the importance of family interaction with the patients and there is little or no room for loved ones to stay close by.

Then I proceeded to show him a short DVD taking him on a virtual tour of what the new Critical Care Center will look like. It takes you into a wide-open reception area with 14 private patient rooms (this is the first leg of renovation on the 4th floor) with a small adjoining room for a family member to stay 24/7...it didn't take long for Henry to look me in the eye and say he would do whatever he could to support this important project.

Board members, physicians, nurses, social workers, hospital administration and past patients all joined with Henry's personal friends and neighbors for cocktails and a lot of conversation about how a new Critical Care Center is imperative to offering top quality healthcare in Central and South Georgia. I wish you all could have been there to experience the passion and commitment expressed by the physicians, nurses and other clinical staff, and even a former patient about the miracles taking place daily in the ICU. Their feelings are so strong, it literally makes me break out in goose bumps as I witness the crowd of Henry's friends nodding their heads in acknowledgement and compassion knowing it could be anyone of them needing an ICU bed in the single moment it takes to be in accident, suffer a stroke, or become extremely ill.

The Time is Right to Look into Making a Charitable Gift Annuity

Finish this statement: “If I had more income, I’d _____” I hope maybe you filled in the blank with something like: “I’d help save lives by making a gift to Medcen Community Health Foundation!” OKAY, maybe that’s not exactly what you were thinking, but please read on, because recently Rob Wall, Board member and Chair of Medcen’s Planned Giving Committee, made a presentation to a group of Carlyle Place Residents focusing on the benefits of setting up a Charitable Gift Annuity. In fact, right now, this is one of the leading ways to make what is called a planned gift.

I sat in the audience as Rob, whose other job is a tax attorney with Smith, Hawkins, Hollingsworth and Reeves, explained in easy to understand terms how a charitable gift annuity works, the benefits, and relevant examples. The concept of making a gift now in order to receive a steady income should be of interest to many of us.

How does it work? Simply:

- The donor makes a gift to the charity (you might want to designate your gift to Carlyle Place, The Children’s Hospital, Hospice of Central Georgia, Critical Care Center or Cancer Life Center).
- The donor receives: a steady income for life and a charitable deduction on income taxes.

What are the benefits?

- **Fixed payments:** Rates are very competitive as compared to other “secure investments.” Rates vary by age and by type of annuity. (Example: Single life rate for an 80 year old man or woman is 7.1%).
- **Taxes:** a portion of the original gift may be deducted from your current year adjusted gross income; a portion of the annuity paid to you is return of principal and not taxed as income; appreciated property is never taxed at capital gains rates; the portion of gain can be spread over the term of the annuity contract.

- **Charity:** Donor may now have the opportunity to witness the impact his/her gift may have. The charity receives the gift immediately and may see benefits before it may utilize the remainder of funds. The Charity (Medcen) can appropriately thank and recognize the donor with membership in the Heritage Circle.
- **Charity:** The charity is able to show the donor how their money will be used. It creates a LEGACY which can be recognized immediately.

Example # 1

72 yr old donor transfers \$100,000 cash to charity in exchange for an annuity.

- The annuity rate is 5.9%
- The donor receives \$5,900 annually.
- For the next 14.5 years, \$4,089 of the annuity is tax-free. \$1,810 would be taxed at the donor’s ordinary income tax rate.
- Donor would be entitled to a charitable deduction of \$40,707

Example # 2

- A couple aged 72 and 75 transfer a cash gift of \$100,000 to a charity in exchange for an annuity for both their lives.
- They receive \$5,400 annually.
- For the next 17.7 years, \$3,723 of the annuity payment is tax-free. \$1,676 would be taxed at the donor’s ordinary income tax rate. After that, the full amount is taxed at ordinary rates.
- Donors would be entitled to a charitable deduction of \$34,102.72.
